

The Department of Forensic Science at Loyola University Maryland (LUM) invites applications for a full-time non-tenure track position as an Assistant Teaching Professor, beginning in August 2024. We are looking for a candidate committed to excellence in undergraduate and graduate education at a dynamic liberal arts university. The search committee is especially interested in candidates who, through their teaching and/or service, will contribute to LUM's stated goals of equity, inclusion, and justice of the academic community.

We seek outstanding candidates who demonstrate the ability to develop and teach new and existing undergraduate and graduate courses in content areas specific to biological forensics and pattern evidence. The successful candidate will teach four courses per term, including two graduate courses in Biological Forensics, Forensic Microbiology, Investigations of Violent Crimes, Pattern Evidence, and/or a course in the candidate's area of specialty, and contribute to introductory courses in forensic science. The successful candidate should possess an awareness of and interest in high impact practices in line with the mission of Jesuit higher education. Faculty development opportunities are also available.

We highly value the ability and motivation to collaborate with other faculty members, the provision of high-value experiences to our undergraduates and graduate students, and a commitment to "inspire students to learn, lead, and serve in a diverse and changing world."
