POSITION DESCRIPTION:

The Town of Marana is seeking a **Crime Scene Specialist** to work in the Police Department. This is a full-time position and an exciting opportunity for those who enjoy being part of a team working to solve crimes and keeping our community safe.

Hiring Range: \$18.38 - \$22.51

Normal work hours: Monday - Friday days; On-call rotation required

EXAMPLES OF DUTIES:

- Transports evidence items for proper shelving; checks packaging to insure evidence is properly stored; and ensures quality control standards are met.
- Responds to crime scenes; documents scenes using photography techniques; collects DNA; discovers and develops latent fingerprints; package and transport evidence. Documents actions in a report.
- Testifies in court; provides evidence for court using imaging software and creates digital media; supports public relations and special events by providing photography or other recording methods.
- Supports vehicle impounds; answers public inquiries; assists the public in retrieving impounded vehicles; assists with property retrieval from the evidence room, and maintains a chain of custody

MINIMUM QUALIFICATIONS:

- High school diploma or GED equivalency plus six months of additional education or training.
- Three or more years of experience in crime scene, law enforcement, professional photography, or closely related field.
- Knowledge and operation of DSLR (Digital Single-Lens Reflex) cameras in manual mode.
- Must pass a physical, 50lb lift test, drug test and respirator exam.
- Valid Arizona Driver license.
- Must pass an extensive background investigation including polygraph, fingerprinting and motor vehicle report.

An equivalent combination of education and relevant experience that provides the desired knowledge, skills & abilities to successfully perform essential functions may be considered.

PREFERRED REQUIREMENTS

- Prior crime scene experience
- Crime Scene Management Certification

RECRUITMENT PROCESS

If you meet the minimum requirements, submit a completed Town of Marana application which can be

supplemented with a resume and cover letter. Candidates are responsible for verifying receipt of materials. Applications must be submitted by applying online at www.maranaaz.gov and following the employment link. All status updates will be sent via email through the applicant tracking system.

REVIEW AND SELECTION PROCESS

- Candidates selected to move forward after the initial screening will be asked to complete a Supplemental Application and Questionnaire which may be used during a background
- · Candidates selected to move forward after the Supplemental Application and Questionnaire review will be invited to a brief phone interview.
- Candidates selected to move forward after the phone interview will be invited to a panel interview and practical photography examination.
- After the panel interview and practical examination, selected candidates will be invited to follow up interviews with department supervisory staff.
- Final candidate selection will advance to an extensive background investigation including a polygraph exam.
