### Debbie Smith Act Reauthorization

The Senate passed the re-authorization bill and it is pending in the House. The House, however, has their own version of Debbie Smith, which has been inserted into the Violence Against Women Act (VAWA). VAWA is working its way through the negotiation process between the House and Senate, but it is not complete. Debbie Smith and the CFSO support the Senate Version of the Debbie Smith Act. We are urging the House to pass the Senate version. Phone calls and other communication to your state representatives are encouraged. If you communicate with the Representatives from your state, please let us know.

## FY20 Federal Forensic Science Budget

The House and Senate Committees have reported out their bills, and the results are below. These numbers will not be final until they are conferenced. Having said that, for the first time the Paul Coverdell Forensic Science Grants are NOT a conference issue. Coverdell has full funding, and the program has the support of the House and the Senate. Thank you to all that have called their Members of Congress. Your voices were heard. So what is the outlook? What is the next step? If all goes as planned, the House and Senate will reconcile their differences and we will have a budget passed before the current Continuing Resolution (CR) expires on November 21. If the Congress cannot meet that deadline, it is likely that the CR will be extended. We will continue to update you.
